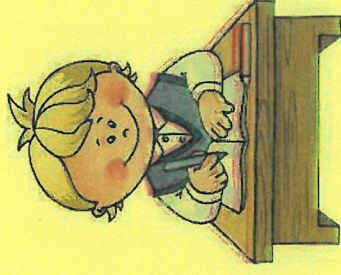

- ✓ Make sure you have a copy of the award letter/s/e-mails (or STO Award Verification Form for each organization) that you received during the 2023-2024 school year. You must submit a copy of this information with your 2024-2025 school year applications. Organizations either email parents or send a letter by US mail of the STO award notifications.
- ✓ Make sure to save all award letters (STO Award Letters) that you receive for the 2024-2025 school year from any organization, you will be asked to submit and include them with the applications for the following school year (2025-2026).

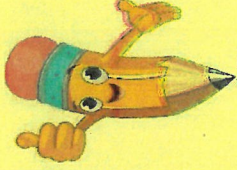

What is required for most applications?

- Application Form (Sometimes one application is required to be completed for each child)
- Proof of Income-(Copy of Income Taxes 2023)
- Copy of STO Letters (Award Verification Letters from Previous Year)
- Other documents (Public School Verification Form-if student is transferring from a public school to IC)

Please send all required forms to the organizations with your applications, if you are missing STO Letters or tax documents the applications will not be processed.

Receiving an email or letter confirmation indicating that your application has been processed and/or completed by an organization does not mean that such organization is required or will award money to your child. All organizations rely on TAX CREDIT DONATIONS FROM THE COMMUNITY AND CORPORATIONS TO BE ABLE TO FUND CHILDREN!
